12. (a) RSL Member

Any person who is a Financial Ordinary member, Associate member or Life member of the Kempsey- Macleay Sub-Branch of the RSL or other Sub- Branches situated within the boundaries of the Kempsey Shire Council and who have supplied proof of their membership status and who is elected as an RSL member.

(b) Associate Member

Associate members shall be persons over the age of eighteen (18) years who have made application for membership of the Club in accordance with these Rules and have been duly admitted.

(d) Bowling Member

Bowling members shall be those persons over the age of eighteen (18) years who have applied for and being elected to bowling membership and who have paid a fee as set out by the Board of Directors from time to time and who are duly registered with the Royal New South Wales Bowling Association or the New South Wales Women’s Bowling Association.

(e) Junior Sporting Member

Junior Sporting members shall be those persons aged between 7 and 18 years and who will be participating in one of the clubs intra-sports clubs. These members must also be accompanied by their parent/guardian and are not permitted to approach any restricted area at either club.

Please Note:

To become an Associate Sub-Branch member of the Kempsey-Macleay RSL Sub-Branch you must already be a full financial member of another Sub-Branch within the Macleay Shire.

For RSL applicants – Original Discharge Certificate/Papers and current Sub-Branch Membership Card **MUST** be produced with application for membership.

For Bowling applicants – The first club you join becomes your mother club as a Full Bowling Member. If you join more than one club as a bowling member then you become a Multi Bowling Member with those clubs.

Applicants (RSL, Bowling, Associate) **MAY** reside out-side the boundaries of the Kempsey Shire.
